## A. 2020-001-Station 310 Remodel/Expansion.

• Chairman Perchorowicz informed the board that the USDA Rural Development Block Grant preapplication is at the General Council and is still in a holding pattern. Chairman Perchorowicz has submitted appropriation request to Representative Kirkpatrick office and is working on the same for Senator Kelly and Senator Sinema offices. The cost was raised 12% to follow inflation.

## C. 2022-003 – Apparatus purchase

• Chief Gunia informed the board that the 2011 F350 ambulance has been put in service. Sam with GEV agreed to send an additional \$3,733.31 for a total of \$10,754.17 to go toward repair of the 2011 F350 ambulance. There was a brief discussion. The board will set the reserve for sale of 2002 ambulance at Aprils meeting. Chief Gunia presented details on 2007 F250 pickup truck to be purchased from Golder Ranch. There was a brief discussion.

-Motion by Clerk Canale, seconded by Member McNurlin to give Chief Gunia authority to negotiate with Golder Ranch to purchase 2007 F250 not to exceed \$10,000 to get it outfitted and in-service. Motion passed 5 to 0.

### D. 2022-011 – FY2022/23 Budget

• Chief Gunia presented the letter form Securis regarding the estimated 2022/2023 contribution amount of \$38,208 which is double from 2021/2022 \$18,271. Chairman Perchorowicz said we should put the cancer risk into station remodel packet. There was a brief discussion regarding a support letter to be sent to Governor Ducey regarding AFDA (Arizona Fire District Association) seeking ARPA funding distribution from Governor's Office for inclusion in Fy23 budget reconciliation bill process for the Fire District Workers Comp Risk Pool.

-Motion by Clerk Canale, seconded by Member Mazza to send a letter of support to Governor Ducey's office regarding ARPA (American Rescue Plan Act) funding distribution to support Fire District Workers Comp Risk Pool. Motion passed 5 to 0.

• Chief Gunia also informed the board employee medical benefits went up \$2,229.04 for 2022/2023.
